CR11-0432 A resolution authorizing and approving the expenditure and payment from the appropriation account designated "liability claims," the sum of Thirty Five Thousand Dollars (\$35,000.00) payable jointly to Mark Ashford and Richard M. Crane, Esq. in full payment and satisfaction of all claims in Civil Action No. 11 CV 1997 in the District Court for the City and County of Denver, Colorado. (HEALTH, SAFETY, EDUCATION & SERVICES)

Dedicates three tracts as public right-of-way in Lowry Filing No. 14 between Dayton, Yosemite and 5th Ave. in Council District 5. The Committee approved filing this resolution by consent on 6-2-11.

CR11-0402 A resolution granting a revocable permit to University of Colorado to encroach into the right-of-way with electrical conduit at 1475 Lawrence Street. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Grants a revocable permit to the Univ. of Colorado at Denver for 605 feet of conduit under the sidewalk at 1475 Lawrence in Council District 8. The Committee approved filing this resolution by consent on 6-2-11.

CR11-0403 A resolution laying out, opening and establishing as part of the city street system certain parcels of land as Evans Ave. and S. Holly St. located at the intersection of Evans Ave. and S. Holly St. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Dedicates public right-of-way as part of Evans and part of Holly at the southeast corner of the intersection for a new 7-Eleven in Council District 6. The Committee approved filing this resolution by consent on 6-2-11.

CB11-0379 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and HSS Inc. related to security guard services at Denver International Airport. (BUSINESS, WORKFORCE & SUSTAINABILITY)

Approves a contract with HSS Inc. to provide auxiliary Security Guard Services at Denver International Airport in the amount of \$83 million from July 16, 2011 to July 15, 2014, with one optional 3-year extension through July 15, 2017. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 6-2-11.

CB11-0415 A bill for an ordinance authorizing expenditures in the Economic Opportunity Special Revenue Fund for the "Temporary Assistance for Needy Families (TANF) Case Management, Employment, and Training FY11-12" program. (BUSINESS, WORKFORCE & SUSTAINABILITY)

Authorizes spending authority in the amount of \$15,436,000 from the U.S. Department of Human Services funds for fiscal year 2011-2012 for the Temporary Assistance for Needy Families (TANF) program. The Committee approved filing this bill by consent on 6-2-11.

General Government & Finance

CB11-0399 A bill for an Ordinance approving a Second Amendatory Agreement by and between the City and County of Denver and eCommerce Systems. (GENERAL GOVERNMENT & FINANCE)

Approves an amendment to the contract with eCommerce Systems, Inc. to extend the term to December 31, 2011 and to increase funding by \$600,000 for a total contract amount of \$1,650,000 to provide on-call technology professional services (OC83016-02). The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 6-2-11.

CB11-0412 A bill for an ordinance amending the 1963 Retirement Plan with regard to definitions (normal retirement), retirement board (composition of advisory committee), retirement categories (normal retirement, early retirement and deferred retirement), retirement benefits (normal retirement, early retirement, deferred retirement and Social Security make-up) and death benefits. (GENERAL GOVERNMENT & FINANCE)

Approves revisions to the Denver Employees Retirement Plan (DERP) for new employees which includes increasing the minimum retirement age to 60, instituting a Rule of 85 for unreduced benefits, increasing the Average Monthly Salary calculation from 3 years to 5 years, eliminating the social security make-up benefit, and requiring a five-year vesting period for all employees; effective July 1, 2011. In addition, the legislation will add one additional member to the Advisory Committee appointed by the Career Service Board. The Committee approved filing this bill at its meeting on 6-1-11.

CB11-0413 A bill for an ordinance amending the 1963 Retirement Plan with regard to the actuarially required contribution. (GENERAL GOVERNMENT & FINANCE)

Approves a 1.5 percent increase to the DERP plan based on a recent actuarial study to meet the Annual Required Contribution (ARC). The additional contribution will increase from 15 percent to 16.5 percent, of covered employees' salary for retirement contributions, to be split (0.75%) equally between the City and employees. The increase will be effective January 1, 2012. The Committee approved filing this bill at its meeting on 6-1-11.

CB11-0414 A bill for an ordinance amending the 1963 Retirement Plan with regard to definitions (accumulated contributions, bridged benefit, credited service, employee, normal retirement, permissive service credit or purchase of service credit and re-numbering of Section 18-402); qualification requirements of the Internal Revenue Code; the retirement board; eligibility; actuarial valuation; retirement categories; retirement benefits; death benefits; monthly payment of benefits; adjustments to benefits; purchase of service credits; denial of benefits; hearing procedures; domestic relations orders; beneficiary designations; and additional technical changes. (GENERAL GOVERNMENT & FINANCE)

Approves an ordinance to amend outdated language and references in the Denver Employee Retirement Plan section of the Denver Revised Municipal Code. The Committee approved filing this bill at its meeting on 6-1-11.

Health, Safety, Education & Services

CB11-0326 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Colorado Coalition for the Homeless, to provide 102 units of tenant based rental assistance to the chronically homeless to obtain and remain in housing. (HEALTH, SAFETY, EDUCATION & SERVICES)

Approves a \$952,680, contract with Colorado Coalition for the Homeless to provide rental assistance and supportive services. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-12-11.

CB11-0336 A bill for an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the State of Colorado concerning the "Community Partnership for Youth in Transition FY2010-11" program and the funding therefor. (HEALTH, SAFETY, EDUCATION & SERVICES)

Accepts a \$13,000 grant from the Colorado Governor's Commission on Community Service for the annual AmeriCorps program. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-16-11.

CB11-0370 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Express Services Inc. dba Express Employment Professionals, to provide temporary employment services. (HEALTH, SAFETY, EDUCATION & SERVICES)

Adds \$200,000 in state funds to the contract with Express Personnel Services for a total contract of \$650,000 for temporary personnel to process applications for assistance. The last regularly scheduled Council meeting within the 30-day period is on 6-27-11. The Committee approved filing this bill by consent on 5-26-11.

Land Use, Transportation & Infrastructure

CB11-0342 A bill for an ordinance approving a second amendatory on-call agreement between Haselden Construction, LLC and the City and County of Denver that will provide general construction services. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Approves a no-cost, two-year extension of the term of the on-call construction services contract with Haselden Construction to June 1, 2013. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-19-11.

CB11-0344 A bill for an ordinance approving an amendatory on-call agreement between FCI Constructors, Inc. and the City and County of Denver that will provide general construction services. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Approves a no-cost, two-year extension of the term of the on-call construction services contract with FCI Constructors to June 1, 2013. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-19-11.

CB11-0375 A bill for an ordinance relating to the Denver Zoning Code, to modify, clarify and consolidate the General Development Plan amendment process. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Amends the Denver Zoning Code to revise the process of amending a portion of an approved General Development Plan (GDP). PUBLIC HEARING AT LEAST FOUR WEEKS FOLLOWING PUBLICATION. The Committee approved filing this bill at its meeting on 5-31-11.

CB11-0376 A bill for an ordinance changing the zoning classification of 65 acres of land located at approximately 53rd Ave. and Memphis Street. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Changes the zoning of 65 acres of land located at approximately 53rd Ave. and Memphis, a portion of the Parkfield Planned Unit Development, from PUD #515 to M-RX-5A in Council District 11. PUBLIC HEARING AT LEAST FOUR WEEKS FOLLOWING PUBLICATION. The Committee approved filing this bill at its meeting on 5-31-11.

CB11-0387 A bill for an ordinance approving an agreement between White Construction Group and the City and County of Denver that will provide improvements at the Cherry Creek Transfer Station. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Approves a \$1,810,000 contract with White Construction Group for improvements at the Cherry Creek Transfer Station, a Better Denver Bond Project in Council District 6. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-26-11.

CB11-0397 A bill for an ordinance approving an amendatory agreement between Augusta Consulting and the City and County of Denver for continued supervision, oversight and management of various Better Denver Bond Program projects. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Increases the contract with Augusta Consulting, LLC, by \$490,000, for a new total of \$980,000, to provide supervision, oversight and management of various Better Denver Bond projects. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 6-2-11.

CB11-0398 A bill for an ordinance relinquishing the easement established in the Permanent Easement recorded at Reception No. 2009028771.

(LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Relinquishes sewer easements that are not required at 4100 Kittredge St. in Council District 11. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 6-2-11.

CB11-0400 A bill for an ordinance vacating Fox St. between 13th Ave. and Speer Blvd., without reservations. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Vacates Fox St. between W. 13th Ave. and Speer at the request of US General Services Administration and following posting of the street in Council District 10. The Committee approved filing this bill by consent on 6-2-11.

CB11-0406 A bill for an ordinance amending Divisions 3 and 4 of Article III of Chapter 56 of the Revised Municipal Code of the City and County of Denver regarding sanitary sewage and storm drainage service charges.

Approves rate increases for sanitary sewer and storm drainage services effective 7-1-11, 1-1-12 and 1-1-13; and provides for the Manager of Public Works to set increases in subsequent years of no more than the regional Consumer Price Index. CB11-0428 A bill for an ordinance changing the zoning classification of 1475 E. Warren Avenue. (LAND USE TRANSPORTATION & INFRASTRUCTURE)

Changes the zoning classification of property located at 4174 E. Warren Ave. from B-4 with waivers & conditions to C-MX-5 in Council District 6. PUBLIC HEARING AT LEAST FOUR WEEKS FOLLOWING PUBLICATION. The Committee approved filing this bill at its meeting on 6-7-11.

CB11-0429 A bill for an ordinance changing the zoning classification of 1835 Franklin Street. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Changes the zoning classification for property at approximately 1835 Franklin, the Exempla Saint Joseph Hospital Campus, from CMP-H, CMP-H2 and H-1-A with waivers to CMP-H and C-MX-8 in Council District 8. PUBLIC HEARING AT LEAST FOUR WEEKS FOLLOWING PUBLICATION. The Committee approved filing this bill at its meeting on 6-7-11.

Approves an amendment to the Airport Use and Facilities Agreement with Mesa Airlines, Inc. to extend the term until 12/31/2011 (AR 25000-2). The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-26-11.

CB11-0380 A bill for an ordinance approving a proposed Second Amendment to Agreement between the City and County of Denver and Hospital Shared Services, Inc. d.b.a. HSS related to the Registered Traveler Program at Denver International Airport. (BUSINESS, WORKFORCE & SUSTAINABILITY)

Approves a contract with HSS Inc. to provide Total Queue Management and Registered Traveler services to the public at Denver International Airport through January 29, 2013, in the amount of \$5.9 million. Approves a cash transfer in the amount of \$250,000 from the Convention Center Payments Special Revenue Fund (Fund 15607) to the Entertainment Grant/Other Capital Projects Fund, and making an appropriation in the Grant/Other Capital Projects Fund for renovations of restaurant space at the Convention Center. The Committee approved filing this bill by consent on 5-19-11.

Health, Safety, Education & Services

CB10-1073 A bill for an ordinance amending Section 18-164 of the Revised Municipal Code, extending the military pay differential for eligible career service employees and members of the classified service through the end of calendar year 2011. (HEALTH, SAFETY, EDUCATION & SERVICES)

Extends the pay differential for civilian and sworn city personnel serving in Afghanistan and/or Iraq conflicts through December 31, 2011. The Committee approved filing this bill by consent on 12-2-10.

CB11-0321 A bill for an ordinance authorizing the issuance of City and County of Denver, Colorado, General Obligation Better Denver Bonds, Series 2011A, for the purpose of financing and/or refinancing and defraying the cost of acquiring, constructing, installing and improving various civic facilities, together with all necessary, incidental or appurtenant properties, facilities, equipment and costs; providing for the levy of general ad valorem taxes to pay the principal of and interest on the Series 2011A Bonds; authorizing the execution of certain agreements and providing other details in connection therewith; ratifying action previously taken relating thereto; providing other matters relating thereto; and making other provisions relating thereto. Amends the agreement with Carnation Building Services, Inc. to increase compensation by \$150,000, for a new total of \$600,000, needed for continuation of custodial services through the end of the contract term, Dec. 31, 2011, and to allow the City to add or delete services as needed, in part due to opening the Stapleton Central Park Recreation Center.
