BR14-0702 *Approves a \$2 million master purchase order with Neve's Uniforms & Equipment through 7-12-16 for police uniforms and equipment (CLOTHING_DPD__0166A0114).

BR14-0710 *Approves a no cost agreement with FC Stapleton II, LLC to facilitate the exchange of the current City-owned parcel for a different parcel to facilitate construction of the North Stapleton fire station in Council District 11 (FINAN-201416696-00).
