A. Mayor's Office - Anthony Aragon

RR15-0679 *Approves the Mayoral reappointments of Benzel Jimmerson and Sudan Muhammad and the appointment of Nicole Frazier, Valmay Hartzog Howard, Molly Moats, and Dwayne Pride, to the Denver African American Commission for terms effective immediately and expiring on 9-26-2017, or until successors are duly appointed.

B. Denver International Airport - Amy Raaz

RR15-0686 *Amends a contract with United Airlines by extending the lease agreement for 3 years, 3 ½ months (for a new end date of 9-30-2018) at an added cost of \$325,000 (new total \$700,000) for the City to continue to occupy space in United's (former Continental) cargo building, being used as a Satellite Security Office. The function of this area is to provide for fingerprinting, testing and issuance of SITA badges (CE 94047).

C. Environmental Health - Diane DeLillio

RR15-0677 *Approves a revenue agreement with Waste Management of Colorado (WM) through 12-31-18 for \$300,000 in revenue (a royalty percentage from composting operations) for WM's operation of a composting facility at the Denver Arapahoe Disposal Site (DADS landfill) (ENVHL-201524286-00).

BR15-0684 *Approves a supplemental appropriation in the amount of \$2,757,585.21 to repay the State for over-reimbursement for administrative costs for eligibility activities associated with Medicaid and Food Assistance (also known as SNAP) (#13008-5511000).
