The last regularly scheduled Council meeting within the 30-day review period is on 3-4-13. The Committee approved filing this bill at its meeting on 1-30-13.

CB13-0059 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Bill Bass Concerts, Inc., to promote and book concerts and live events at various City venues and facilities.

Approves a contract with Bill Bass Concerts, Inc., (the "Promoter") for the Arts & Venues Denver Promoter Commission Program (THTRS-201209262). CB13-0030 A bill for an ordinance approving a proposed First Amendment to Agreement between the City and County of Denver and the United States of America, General Services Administration related to office space at Denver International Airport.

Extends the World Port Lease for nine months to terminate on August 25, 2013 for \$163,604.83 in additional revenue (AR2A000(01)). The last regularly scheduled Council meeting within the 30-day review period is on 3-4-13. The Committee approved filing this bill by consent on 1-31-13.

Adds \$199,364 to the contract with Syscon Justice Systems, Inc., (through December 31, 2013) for maintenance of the Jail Management System software (CE-76012-05). The last regularly scheduled Council meeting within the 30-day review period is on 3-4-13. The Committee approved filing this bill by consent on 1-31-13.

CB13-0063 A bill for an ordinance establishing a "Denver Employee Fitness Center" fund in the Culture and Recreation Special Revenue Fund and the means for authorizing expenditures from such fund; and making a transfer of cash from the General Government Special Revenue Fund to the Culture and Recreation Special Revenue Fund.

Transfers remaining cash balance for the Wellness Center from the Wellness Program special revenue fund in the Office of Human Resources to a new fund in the Department of Parks and Recreation to reflect the transfer of operations of the Wellness Center. CB13-0072 A bill for an Ordinance approving a Purchase and Sale Agreement with The George W. Clayton Trust, by its Trustee Clayton Early Learning, and the Regional Transportation District for the sale of certain property located on the north and west edges at the Park Hill Golf Course for the construction of the East Corridor FasTracks Project.

Approves a Purchase and Sale Agreement for \$935,000 with The George W. Clayton Trust and the Regional Transit District for property located at the Park Hill Golf Course for the benefit of the FasTracks Project in Council District 8. The last regularly scheduled Council meeting within the 30-day review period is on 3-4-13. The Committee approved filing this bill at its meeting on 2-6-13.

CB13-0073 A bill for an Ordinance approving an Agreement for Grant of Easement with The George W. Approves an amendment to the Bluff Mercy, LLC contract to add \$331,192.00 for total contract amount of \$604,586.00 to subsidize 91 housing units and for associated case management services for program residents (SOCSV-2011-03957-01). Amends a contract with Jacobs Project Management to extend the term from June 1, 2013 to Dec. 31, 2013, with no additional cost, to complete various projects (CE85030-3). The last regularly scheduled Council meeting within the 30-day review period is on 3-4-13. The Committee approved filing this bill by consent on 12-27-12.

CB13-0045 A bill for an ordinance approving a proposed on-call agreement between the City and County of Denver and Gilmore Construction Corporation, to perform construction services on an "as needed" or "on-call" basis.

Approves a 3-year, \$5,000,000 maximum on-call construction contract with Gilmore Construction Corp (201208985). The last regularly scheduled Council meeting within the 30-day review period is on 3-4-13. The Committee approved filing this bill by consent on 1-24-13.

CB13-0046 A bill for an ordinance approving a proposed on-call agreement between the City and County of Denver and Wilderness Construction Co., to perform construction services on an "as needed" or "on-call" basis.

Approves a 3-year, \$5,000,000 maximum on-call construction contract with Wilderness Construction Co. (201208976). The last regularly scheduled Council meeting within the 30-day review period is on 3-4-13. The Committee approved filing this bill by consent on 1-24-13.

CB13-0047 A bill for an ordinance approving a proposed on-call agreement between the City and County of Denver and Ash & White Construction Co., to perform construction services on an "as needed" or "on-call" basis.

Approves a 3-year, \$5,000,000 maximum on-call construction contract with Ash and White Construction Group (201208977). The last regularly scheduled Council meeting within the 30-day review period is on 3-4-13. The Committee approved filing this bill by consent on 1-24-13.

CB13-0050 A bill for an ordinance approving a proposed on-call agreement between the City and County of Denver and Milender White Construction Co., to perform construction services on an "as needed" or "on-call" basis.

Approves a 3-year, \$5,000,000 maximum on-call construction contract with Milender White Construction (201208981). The last regularly scheduled Council meeting within the 30-day review period is on 3-4-13. The Committee approved filing this bill by consent on 1-24-13.

CB13-0051 A bill for an ordinance approving a proposed on-call agreement between the City and County of Denver and Interlock Construction Corp., to perform construction services on an "as needed" or "on-call" basis.

Approves a 3-year, \$5,000,000 maximum on-call construction contract with Interlock Construction Corp. (201208982). The last regularly scheduled Council meeting within the 30-day review period is on 3-4-13. The Committee approved filing this bill by consent on 1-24-13.

CB13-0052 A bill for an ordinance approving a proposed on-call agreement between the City and County of Denver and Haselden Construction, LLC, to perform construction services on an "as needed" or "on-call" basis.

Approves a 3-year, \$5,000,000 maximum on-call construction contract with Haselden Construction (201208983). The last regularly scheduled Council meeting within the 30-day review period is on 3-4-13. The Committee approved filing this bill by consent on 1-24-13.

CB13-0053 A bill for an ordinance approving a proposed on-call agreement between the City and County of Denver and FCI Constructors, Inc., to perform construction services on an "as needed" or "on-call" basis.

CB12-0953 A bill for an ordinance changing the zoning classification for 1239 Bruce Randolph Avenue.

Changes the zoning classification from U-SU-A-1 (Urban context, single unit, minimum lot of 3,000 sq. ft.) to U-MX-3 (Urban context, mixed use, maximum 3 stories) for property at 1239 Bruce Randolph Ave. in Council District 8. The Committee approved filing this bill at its meeting on 12-18-12.

Approves a support facilities lease agreement with Swissport Cargo Services, LP, a cargo handler that provides services to commercial flights (AR 15004 (1)). The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing the bill at its meeting on 1-23-13.

CB13-0023 A bill for an ordinance approving a proposed First Amendment to Contract between the City and County of Denver and John Rohrer Contracting Company, Inc. related to on-call construction services at Denver International Airport.

Approves a one-year, no cost extension (to a total of three years) of the \$12,000,000 contract with John Rohrer Construction Company for terminal roadway moisture protection and repairs at Denver International Airport (DIA) (PLANE-201102006). The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing this bill by consent on 1-24-13.

CB13-0024 A bill for an ordinance approving a proposed Non-Disturbance, Attornment and Concession Agreement between the City and County of Denver and Skyport Development Company, LLC for a concession at Denver International Airport.

Approves a non-disturbance, attornment and concession agreement with Skyport Development Company, LLC and Denver International Airport (DIA) Steakhouse, LLC (PLANE-201208478) to allow the sublease to become a direct lease when the agreement with Skyport Development Company, LLC (AC69004) expires on October 31, 2017. The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing the bill at its meeting on 1-23-13.

CB13-0025 A bill for an ordinance approving a proposed Non-Disturbance, Attornment and Concession Agreement between the City and County of Denver and Skyport Development Company, LLC for a concession at Denver International Airport.

Approves a non-disturbance, attornment, and concession agreement with Skyport Development Company, LLC and FM Wok, LLC (PLANE-201208465) to allow the sublease to become a direct lease with the City and County of Denver when the agreement with Skyport Development Company, LLC (AC69004) expires on October 31, 2017. The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing the bill at its meeting on 1-23-13.

CB13-0026 A bill for an ordinance approving 19 proposed Airport Use and Lease Agreements between the City and County of Denver and certain airlines related to operations and leased space at Denver International Airport.

Executes airport use and lease agreements with 19 commercial airlines that provide commercial flight service at the airport. The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing the bill at its meeting on 1-23-13.

CB13-0027 A bill for an ordinance approving a proposed Agreement for On-Call Environmental Design Services between the City and County of Denver and Brown & Caldwell, Inc. related to on-call environmental services at Denver International Airport.

Approves a three-year, \$1,050,000 on-call environmental services contract with Brown and Caldwell, Inc., for environmental services at Denver International Airport and the former Stapleton Airport (201208638). The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing this bill by consent on 1-24-13.

CB13-0028 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Waste Management of Colorado, Inc. related to special waste disposal services for Denver International Airport and the former Stapleton International Airport.

Approves a four year, \$3,000,000 special waste disposal contract with Waste Management Co., Inc. for disposal of special airport waste at the Denver Arapahoe Disposal Site. The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing the bill at its meeting on 1-23-13.

CB13-0029 A bill for an ordinance approving a proposed Contract between the City and County of Denver and FCI Constructors, Inc. related to on-call construction services at Denver International Airport.

Approves a three-year, \$15,000,000 on-call construction contract with FCI Constructors, Inc. (201208782). The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing this bill by consent on 1-24-13.

Government & Finance

CB13-0034 A bill for an ordinance establishing a "Metro Mortgage Assistance Plus Program" fund in the General Government Special Revenue Fund and the means for authorizing expenditures from such fund.

Establishes a new "Metro Mortgage Assistance Program" special revenue fund in the General Government Special Revenue Fund. The Committee approved filing this bill by consent on 1-24-13.

CB13-0068 A bill for an ordinance rescinding budget, transferring cash and making appropriations in the General Fund, General Government, Culture and Recreation, and Public Safety Special Revenue Funds and Capital Improvements and Capital Maintenance Fund of moneys designated by City Council for various projects.

Approves the City Council 2012 year-end close out budget reconciliation by transferring \$189,900 of City Council budget savings to City Council Special Revenue Funds, transferring \$47,500 of City Council budget savings to other city funds, and expending \$41,420 from City Council Special Revenue Funds on a variety of City projects. City Council is giving back \$62,338.19 of 2012 budget savings to the 2013 General Fund. The Committee approved filing this bill by consent on 1-31-13.

Health, Safety, Education & Services

CB12-0902 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Mental Health Center of Denver to provide services to chronically homeless persons.

Amends the Mental Health Center of Denver contract to add \$850,292, for a total contract of \$3,368,412.38, to provide housing and treatment services to 75 chronically homeless individuals (SOCSV-CE01060-03). The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing this bill by consent on 11-29-12.

CB12-0976 A bill for an ordinance authorizing the Mayor and other proper officials of the City and County of Denver to enter into a Collective Bargaining Agreement with the Denver Police Protective Association for the years 2013 and 2014.

Approves the Collective Bargaining Agreement with the Denver Police Protective Association for the years 2013 and 2014. The Committee approved filing this bill at its meeting on 1-22-13.

CB12-0977 A bill for an ordinance authorizing the Mayor and other proper officials of the City and County of Denver to enter into a Collective Bargaining Agreement with the Fraternal Order of Police, Denver Sheriff Lodge 27 for the years 2013 and 2014.

Approves the Collective Bargaining Agreement with the Fraternal Order of Police, Denver Sheriff Lodge 27 for the years 2013 and 2014. The Committee approved filing this bill at its meeting on 1-22-13.

CB12-0988 A bill for an ordinance establishing the Denver Immigrant and Refugee Commission within the Agency of Human Rights and Community Partnerships.

Amends the Agency for Human Rights & Community Partnerships ordinance to create a new commission to be called the Denver Immigrant and Refugee Commission. The Committee approved filing this bill at its meeting on 1-8-13.

CB13-0031 A bill for an ordinance approving an Amendatory Agreement with Integral Recoveries, Inc. to extend the term through February 2014 providing debt collection services to Denver County Court.

Amends the contract with Integral Recoveries, Inc., to extend the term through February 2014 to provide services for Denver County Court related to collecting delinquent fines and fees (201204950). The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing this bill by consent on 1-24-13.

CB13-0032 A bill for an ordinance approving a proposed Second Amendatory Agreement between the City and County of Denver and Senter Goldfarb & Rice, LLC, to provide professional legal services in matters assigned by the City Attorney.

Amends the contract with Senter Goldfarb & Rice to increase the contract amount by \$350,000 for a total contract cost of \$1,150,000 to provide legal services (CE13018). The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing this bill by consent on 1-24-13.

CB13-0033 A bill for an ordinance approving a proposed Second Amendatory Agreement between the City and County of Denver and Ingram Library Services, Inc., to extend the term through December 31, 2013 and increase the maximum amount of the agreement to \$5,945,000.

Amends the contract with Ingram Library Services, Inc., to extend the agreement through December 31, 2013 and to add \$3,045,000 for a total contract of \$5,945,000 for book purchases and cataloging services for the Denver Public Library (201103203-02). The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing this bill by consent on 1-24-13.

CB13-0037 A bill for an ordinance approving a proposed Eleventh Amendatory Agreement between the City and County of Denver and the Jefferson County Sheriff's Department for law enforcement services in the Denver Mountain Parks System.

Approves an eleventh amendment to the Jefferson County Sheriff's Department contract to add three years through December 31, 2015 for a total contract amount of \$579,213 for law enforcement services in the Denver Mountain Parks system (POLIC CE-31245-11). The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing this bill by consent on 1-24-13.

CB13-0040 A bill for an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and The Colorado Health Foundation concerning the "SNAP Into Health" program and the funding therefore.

Accepts \$845,062 from The Colorado Health Foundation to initiate the SNAP Into Health Nutrition based program which is designed to improve access to health care and nutrition for Denver's underserved populations (SOCSV-2012-08965). The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing this bill by consent on 1-24-13.

Land Use, Transportation & Infrastructure

CB12-0951 A bill for an ordinance approving a Long-Term License (56th Avenue Pond, Pipelines and Channel) from the City and County of Denver to the Park Creek Metropolitan District.

Approves a license agreement with the Park Creek Metropolitan District and Forest City Stapleton that provides access to city-owned property south of 56th Ave. and west of Dallas St. to construct drainage improvements (the area will eventually become a City park) related to future construction of the Stapleton High School in Council District 11. The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing this bill by consent on 12-20-12.

CB13-0019 A bill for an Ordinance amending Ordinance Number 426, Series of 2007, as amended by Ordinance Number 335, Series of 2009, Ordinance Number 148, Series of 2010, Ordinance Number 11, Series of 2011, Ordinance Number 258, Series of 2011, and Ordinance Number 630, Series of 2011 designating the project to be undertaken and funded with the proceeds of the Better Denver bonds.

Amends Ordinance Number 426, Series of 2007, as amended, designating the projects funded through Better Denver bonds, to amend allocations regarding cultural facilities, including nine new bond projects. The Committee approved filing this bill at its meeting on 1-15-13.

CB13-0042 A bill for an ordinance approving a Second Amendatory Agreement between the City and County of Denver and HNTB Corporation for the Colorado Center Bicycle/Pedestrian Bridge over I-25.

Amends the contract with HNTB Corporation for the Colorado Center Bicycle/Pedestrian Bridge over I-25 to extend the term from July 1, 2013, to December 31, 2015, and add \$321,968, for a new maximum of \$1,831,600, for additional professional design services (CE92032-02). The last regularly scheduled Council meeting within the 30-day review period is on 2-25-13. The Committee approved filing this bill by consent on 1-24-13.
