I. DEPARTMENTAL MATTERS IN THE REGULAR COURSE OF BUSINESS:

A. Mayor's Office - Anthony Aragon

RR16-0228 *Approves the Mayoral appointments of Kenneth Arellano, Jr. and Dollar Lee to the Denver Asian Pacific American Commission for terms effective immediately and expiring 1-22-18, or until successors are duly appointed.

B. Community Planning and Development - Theresa Lucero/ Curt Upton

BR16-0216 Rezones property at 4800 Race Street from I-B, UO-2 to C-MX-3, C-MX-5, and C-MX-8 in Council District 9.

BR16-0217 Rezones property at 5104 Dallas Street from M-RX-5 to I-MX-3 in Council District 8.

BR16-0219 Rezones property at 4353 N. Cherokee St. from I-A, UO-2 to C-RX-8 in Council District 9.

C. Denver International Airport - Aaron Barraza

BR16-0224 *Amends Section 5-18 of the Denver Revised Municipal Code concerning privately financed commercial improvements on Denver International Airport land.

BR16-0225 *Amends Section 5-37 of the Denver Revised Municipal Code concerning limitations on development within the Airport Influence Overlay District.

D. Office of Children's Affairs - Chris Auer

BR16-0232 *Amends a contract with the Denver Health and Hospital Authority to extend the contract term ten months through 12-31-16 and increase funding in the amount of \$56,405.06 for a new total of \$785,764.44 for health care and developing school readiness for Denver Great Kids Head Start Program (MOEAI – 201311626-03).

E. Office of Economic Development - Susan Liehe

RR16-0231 *Approves a 40-year loan to Mental Health Center of Denver for \$600,000 to provide construction and permanent financing on a 60-unit affordable rental housing project located at 1601 South Federal Boulevard in Council District 2 (OEDEV – 201525041-00).

F. Office of Human Resources - Nicole Keane/ Alena Duran

BR16-0205 Amends the classification and pay plan by adding Police Video Operator (613-N) and Lead Police Video Operator (614-N) who will be responsible for monitoring live video, storing and accessing video recordings, and storing data recorded from police officer body cameras.

G. Parks and Recreation - Yolanda Quesada/ Bob Finch

RR16-0227 *Extends the contract with Outward Bound, Inc. through 9-28-21 and adds a snow removal provision to lease the lodge building and parking lot at Camp Rollandet Natural Area with no change in the lease amount (201102078).

BR16-0154 Approves an intergovernmental agreement with the Colorado Department of Transportation for land transactions and underpass construction for the South Platte Regional Trail and roadway improvements between South Jason Street and South Huron Street for the I-25/Santa Fe and Alameda Avenue Interchange Project in Council District 7 (201626220).

H. Public Works - Angela Casias

BR16-0229 *Approves a five-year \$913,972.80 intergovernmental agreement with the Colorado Department of Transportation through 06-30-21 to reimburse the City for ongoing maintenance of signs and pavement markings on state highways within Denver (20162727).

BR16-0230 *Approves a five-year \$5,427,000 intergovernmental agreement with Colorado Department of Transportation through 06-30-21 to reimburse the City for ongoing maintenance of traffic signals on state highways within Denver (201627276).

RR16-0226 *Grants a revocable permit to Denver Bike Sharing to encroach into the public right-of-way with a bicycle docking station at 1651 Wynkoop Street in Council District 9.
