#### A. Environmental Health - Lisa Straight

BR16-0318 \*Amends an intergovernmental agreement with the State of Colorado by extending the contract term for an additional year through 06-30-17 and adding an additional \$640,641 to the revenue amount for a total of \$1,207,003 for reimbursement for the Department of Environmental Health's Public Health Inspection Division's Child Care Facility Inspection Program to provide services related to childcare facility inspections (ENVHL-201521228-01).

BR16-0322 Amends the Welton Corridor Urban Redevelopment Plan for the 2560 Welton Street Project in Council District 9.

BR16-0323 Approves the 2560 Welton Street Property Tax Increment Area and Sales Tax Increment Area Cooperation Agreement with the Denver Urban Renewal Authority for the 2560 Welton Street Project to establish, among other matters, the parameters for tax increment financing with incremental property taxes and incremental sales taxes in Council District 9.

BR16-0324 Approves the 2560 Welton Street Intergovernmental Agreement among Denver Urban Renewal Authority, the City and County of Denver and School District No. 1 for the 2560 Welton Street Project to establish, among other matters, the parameters for tax increment financing with incremental property taxes, in Council District 9.

BR16-0325 Approves the 2560 Welton Street Letter of Agreement among Denver Urban Renewal Authority ("DURA"), the City and County of Denver and Urban Drainage and Flood Control District ("UDFC") for the 2560 Welton Street Project to establish, among other matters, the parameters for tax increment financing with incremental property taxes in Council District 9.

BR16-0326 \*Appropriates \$7,151,000 of the Federal Head Start grant to operate the Denver Great Kids Head Start program through the Office of Children's Affairs to provide services to 1,153 children in the established service area.

BR16-0327 \*Approves a contract with Mile High Montessori Early Learning Centers for full funding in the amount of \$1,682,721 through 6-30-17 to provide direct Head Start services to 269 children (MOEAI 201626987).

BR16-0328 \*Approves a contract with Catholic Charities and Community Services of the Archdiocese of Denver for full funding in the amount of \$1,510,802 and through 6-30-17 to provide direct Head Start services to 224 children (MOEAI 201626971).

BR16-0329 \*Approves a contract with Clayton Early Learning for full funding in the amount of \$1,424,825 and through 6-30-17 to provide direct Head Start services to 236 children (MOEAI 201626973).

BR16-0330 \*Approves a contract with School District Number One for full funding in the amount of \$1,722,046 and through 6-30-17 to provide direct Head Start services to 302 children (MOEAI 201626986).
