A. Mayor's Office - Anthony Aragon

RR11-0615 *Approves the following mayoral re-appointments and new appointments to the Denver Gay, Lesbian, Bisexual & Transgender (GLBT) Commission for a term effective immediately and expiring May 1, 2013: Re-appointments: Rachel Chaparro, Erin Iwata, Erica Johnson, Santiago Lopez, Patrick Oakes and Dorelle Raab-Peters; and new appointments: Charlen Byron, Rene Hickman, Michael Nicoletti, David Remson, David Sevick and Mark Valentine.

B. Community Planning and Development - Chris Gleissner

BR11-0606 Amends the Zoning Map to rezone property at 75 Adams Street from PUD #304 to C-MX-8 in Council District 10.

BR11-0605 Amends the Zoning Map to rezone property at 3155 E 1st Ave. from PUD #151 to C-CCN in Council District 10.

C. Denver International Airport - Guadalupe Gutierrez/Brian Elms

BR11-0607 *Authorizes the Manager of Finance to issue for the City and County of Denver, for and on behalf of its Department of Aviation, Airport Revenue Refunding Bonds, Series 2011B-D in an amount not to exceed \$650 million for the purpose of refunding outstanding Series 1998, 2001 and 2002 Airport Revenue bonds.

BR11-0609 *Approves a \$575,000 contract amendment with Airport and Aviation professionals, Inc to extend the contract for two years for services as an Airline Liaison Office, representing the airlines' collective views while facilitating the airline/airport relationship as a business partnership.

BR11-0610 *Approves a \$378,938.00 contract amendment with the U.S. Department of Agriculture to address wildlife hazards in the vicinity of the airport.

D. Economic Development - Seneca Holmes

RR11-0611 *Approves a \$600,000 contract with Denver Urban Renewal Authority to provide low or no interest rehabilitation loans to income-qualified homeowners using federal HOME funding.

E. Emergency Management - Lin Bonesteel

BR11-0602 *Accepts the FY 11-12 Incident Management Team pilot project grant award of \$250,000 from FEMA for the Office of Emergency Management to provide regional training and exercise funds for Incident Management Teams.

F. Facilities Planning - Andrew Johnston

RR11-0614 *Authorizes the City to roll-over to future years its 2011 Private Activity Bond

allocation of \$29,385,875 from the Colorado's Department of Local Affairs.

G. General Services - Melissa Bordwine

BR11-0608 *Extend for one year the contract with Community Mediation Concepts to provide mediation services for City agencies for \$8,291.67 per month while an RFP is conducted for a new contract for the citywide services.

H. Public Works - Stacie Loucks/Brendan Kelly

BR11-0603 *Approves an Intergovernmental Agreement with the University of Colorado at Denver to provide student interns on an on-call basis for work in the Engineering Division of the Public Works Department.

RR11-0616 *Grants a revocable permit to DaVita, Inc. to encroach into the public right-of-way with a permanent roof structure overhang at 2000 16th Street in Council District 9.
